This track is dedicated to research on cyber-threats in the context of Maritime systems, information technology to operational technology, and offshore to onshore infrastructure. The intention of this tract is to bring researches together from academia, industry, and government to present ongoing research on the maritime systems of today, but also the threats they may face in the future, and regulatory experts to advance the state-of-the-art of cyber-physical systems.
