



# Example Automated Fingerprint Identification System (AFIS)

**Proposition No. 1** 

Regional Automated Fingerprint Identification System (AFIS) Levy

The King County Council has passed Ordinance No. 19884 concerning this proposition for the regional automated fingerprint identification system (AFIS) levy. This proposition would fund the continued operation of the AFIS program to provide enhanced forensic fingerprint and palmprint technology and services to aid in the administration of justice. It would authorize an additional property tax for seven years beginning in 2026 at \$0.0275 per \$1,000 of assessed valuation, use the 2026 levy amount to compute limitations under Chapter 84.55 RCW for subsequent levies in 2027-2032, and exempt eligible seniors, veterans, and disabled persons under RCW 84.36.381. 
